

Corazon was engaged by a cardiovascular physician practice to expand their existing Ambulatory Surgery Center (ASC) by adding invasive cardiology services. This expansion aimed to enhance the practice's service offerings and improve patient care through the development of a new cardiac cath lab within their existing ASC. Situation:

The surgery center faced significant challenges in adding expanded cardiology services to their existing ASC. The administrative leadership lacked the necessary experience in ASC regulatory compliance. This gap led to state regulatory compliance issues. The initial attempts by the center to handle these issues independently resulted in further delays in opening the new cath lab and were very resource intensive.

Interventions:

Corazon launched support with a thorough readiness assessment of the practice's overall ASC compliance status, followed by the development of a detailed plan to address deficiencies in achieving adherence to federal and state standards. Corazon further prepared the center for state inspections by formulating responses to state compliance requests. Specific state requirements, including typical life safety items and general ASC compliance, were addressed to meet all regulatory standards.

During the implementation phase, Corazon guided the center through the state requirements, as well as the usual staffing, staff education, facility, equipment selection, and policy development needs that are necessary in any new service start-up. The team provided the necessary expertise and support to help the center meet the regulatory requirements successfully. This included integrating the ASC and Corazon's Cath/PCI accreditation process into the project timeline, preparing for surveys, and addressing potential issues proactively to ensure a smooth accreditation process. The entire project, including the ASC readiness assessment and the implementation of the new cardiac catheterization lab, was completed on time and on budget.
