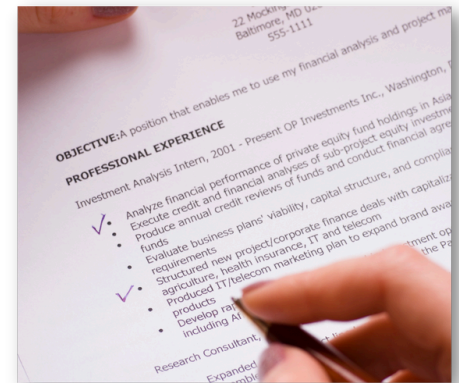

Position Summary:

Position Requirements:

A Bachelor's Degree in Nursing, Radiologic Technology with Advanced Level Cardiac Interventional Radiography, or Registered Cardiovascular Invasive Specialists was required. A Master's Degree in healthcare related field was preferred. The candidate must have three years of experience in cardiovascular healthcare management, previous experience in new Cath lab development, and the ability to assist in clinical functions.
