The Beginning

To ensure the success of a Percutaneous Coronary Intervention (PCI) Program, the Corazon Consulting team created a business plan that carefully laid out the financial viability and operational requirements. After a four-month planning period, the Corazon team was able to recommend the PCI program was a practical next step in the enhancement of their interventional cardiology unit. Corazon then assisted in the application of the Certificate of Need (CON) for the program.


Next Steps

The recruitment team identified five candidates for the Cardiovascular Service Line Director position, as well as two candidates for the Interventional Cardiologist position. Orangeburg accepted a Corazon-presented individual for each opening. During this process, the candidates were screened to ensure they met all necessary guidelines to guarantee a successful interventional cardiology (PCI/STEMI) program.



The consulting team worked in tandem with the onboarding of the Interventional Cardiologist to determine Orangeburg's ability and readiness to implement the PCI program. From there, they were able to take the prior business plan and execute the program to ensure advanced cardiology services to the surrounding community.

Corazon was able to successfully place two cardiovascular candidates in conjunction with a strategic plan for the expansion of Orangeburg's PCI program. With this, they were able to implement a successful program with the first PCI performed January 2023. This milestone is a huge leap forward for interventional cardiovascular services provided in the Orangeburg regional area.
